Childcare vouchers worth £55 per week are easily available for parents and we encourage all parents to look into this.

THESE ARE ONLY AVAILABLE TO PARENTS SIGNED UP BY 31ST AUGUST 2018; but doing so will last until no longer required.

If you choose to sign up for one of these schemes you should save considerable sums. It is reckoned that you can save £900 per year of tax & Natl Insurance by using vouchers, assuming you earn £155 per week.

Once you sign up, you then inform the voucher operator of your child care costs (that is - our invoice), whereupon they invoice your employer. If/when you advise them that costs have changed (for example during holiday time) they invoice accordingly. All is done online.

Your employer pays this sum to the voucher operator, and then will deduct this from your gross income. Only then will your employer start applying tax (20%) and National Insurance (12%) deductions on what remains of your income. So they don't deduct 32% on the money paid to the voucher operator.

The Voucher operator then pays Zeals Youth Trust direct in your name.
